The shop area extends to 682.3 sq feet with a door leading into a central lobby area, which has been previously used for storage. From here there is a ground floor reception room that the owner uses as a sitting room, with an adjacent bathroom. There is access out to a small courtyard area via side door. Stairs rise up from the central lobby to a kitchen area with a selection of fitted units. Leading from here you enter a large bed-sitting room. There is additional storage space in the large loft, which is accessed by a fixed ladder.

For any cash buyers seeking a suitable investment in a bustling town, look no further than this freehold, terraced, two storey building.



Approx. 63.4 sq. metres (682.3 sq. feet)




First Floor

This property is for sale by the Modern Method of Auction. Should you view, offer or bid on the property, your information will be shared with the Auctioneer, iamsold.

This method of auction requires both parties to complete the transaction within 56 days of the draft contract for sale being received by the buyers solicitor. This additional time allows buyers to proceed with mortgage finance (subject to lending criteria, affordability and survey).

The buyer is required to sign a reservation agreement and make payment of a non-refundable Reservation Fee. This being 4.2% of the purchase price including VAT, subject to a minimum of £6,000.00 including VAT. The Reservation Fee is paid in addition to purchase price and will be considered as part of the chargeable consideration for the property in the calculation for stamp duty liability.

Buyers will be required to go through an identification verification process with iamsold and provide proof of how the purchase would be funded.

The buyer will also make payment of £300.00 including VAT towards the preparation cost of the pack, where it has been provided by iamsold.
